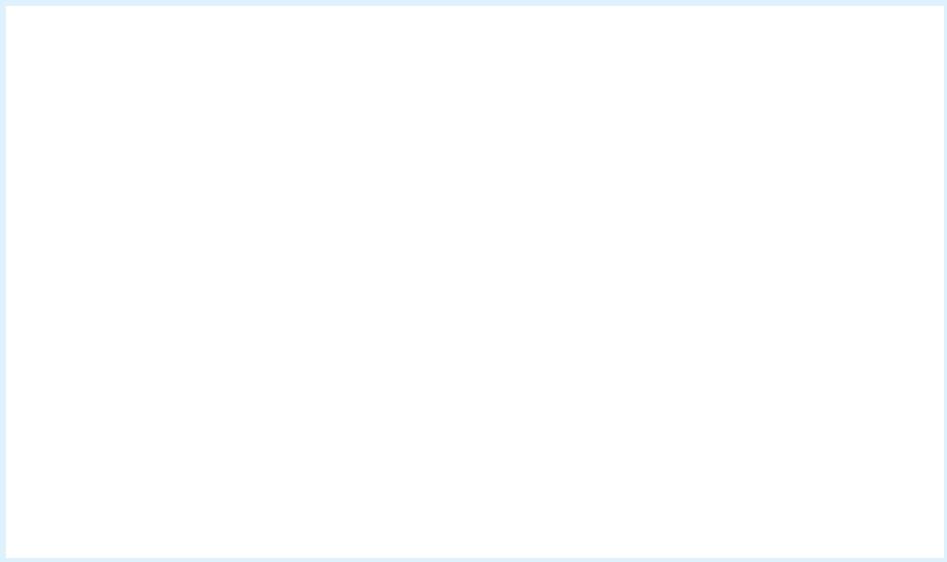


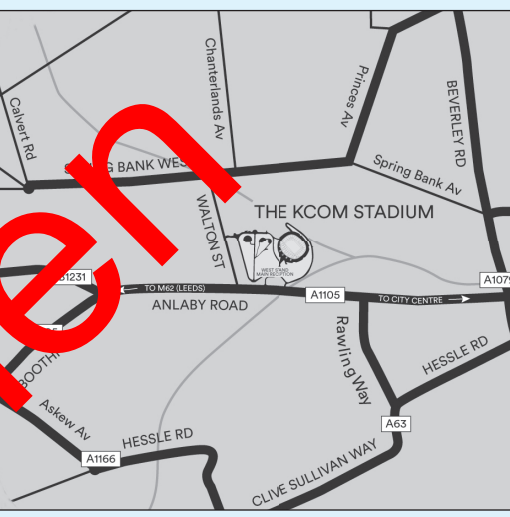

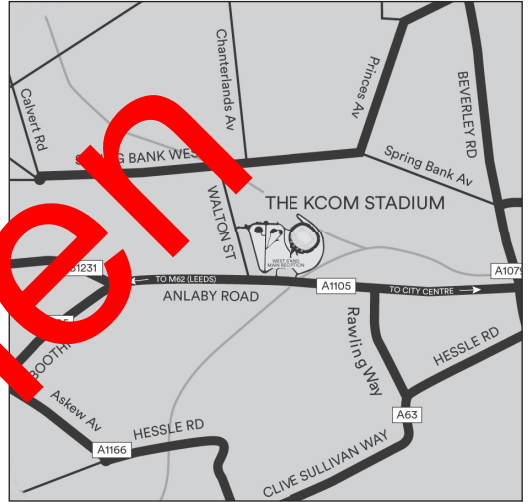

Notes to Form of Proxy

1. Full details of the General Meeting Resolution to be proposed at the General Meeting, with explanatory notes, are set out in the Notice of General Meeting which is set out in Appendix 7 to the Scheme Document relating to the Scheme. Before completing this Form of Proxy, please also read "Action to be taken" set out on pages 8 to 10 of the Scheme Document. Terms defined in the Scheme Document shall apply in this Form of Proxy unless the context otherwise requires.
2. Only KCOM Shareholders, or their duly appointed representatives, are entitled to attend, speak and vote at the General Meeting. A KCOM Shareholder may appoint one or more proxies (provided that each proxy is appointed to exercise rights attached to a different share or shares), who need not be KCOM Shareholders, to exercise all or any of his/her rights to attend, speak and vote on his/her behalf. Proxies may only be appointed using the procedures set out in this Form of Proxy. If the proxy is being appointed in relation to less than your full voting entitlement, please enter in the box next to the proxy holder's name the number of shares in relation to which they are authorised to act as your proxy. If left blank, your proxy will be deemed to be authorised in respect of your full voting entitlement (or, if this Form of Proxy has been issued in respect of a designated account for a KCOM Shareholder, the full voting entitlement for that designated account). The Form of Proxy gives your proxy(ies) full rights to attend, speak and vote. This Form of Proxy (i) in the case of an individual must be signed by the appointor or his attorney or authenticated in accordance with the KCOM Articles; and (ii) in the case of a corporation must be either given under its common seal or otherwise in accordance with Section 44 of the Companies Act 2006 or be signed on its behalf by an attorney or a duly authorised officer of the corporation or authenticated in accordance with the KCOM Articles. Any signature or authentication of such appointment need not be witnessed. Where an appointment of a proxy is directed on behalf of the appointor by an attorney, the power of attorney or a copy thereof certified nottally or in some other way approved by the directors must (unless previously registered with the Company) be submitted to and arrive no later than 48 hours before the Meeting (excluding any part of a day which is not a Business Day) at Link Asset Services, The Registry, 34 Beckenham Road, Beckenham, Kent, BR3 4TU, failing which the appointment will be treated as invalid.
4. The appointment of a proxy will not prevent a KCOM Shareholder from subsequently attending and voting at the General Meeting in person. If a KCOM Shareholder appoints a proxy or proxies and then decides to attend the General Meeting in person and vote on a poll using his/her poll card, then the vote in person will override the proxy vote(s). If the vote in person is in respect of the KCOM Shareholder's entire holding then all proxy votes will be disregarded. If, however, the KCOM Shareholder votes at the meeting in respect of less than the KCOM Shareholder's entire holding, and the KCOM Shareholder indicates on his/her poll card that all proxies are to be disregarded, that shall be the case; but if the KCOM Shareholder does not specifically revoke proxies then the vote in person will be treated in the same way as if it were the last received proxy and earlier proxies will only be disregarded to the extent that to count them would result in the number of votes being cast exceeding the KCOM Shareholder's entire holding.
5. To be valid, the Form of Proxy, and any power of attorney or other authority under which it is executed (or a duly certified copy of any such power or authority), must either be (a) sent (or delivered by hand during normal business hours) to the Company's registrars, Link Asset Services, 34 Beckenham Road, Beckenham, Kent, BR3 4TU or (b) lodged using the CREST electronic proxy appointment services in accordance with the procedures set out in the CREST Manual or (c) be lodged using the shareholder portal at www.kcom-shares.com, in each case, so as to arrive no later than 11.15 a.m. (London time) on 9 July 2019 or, if the General Meeting is adjourned, 48 hours (excluding any part of a day that is not a Business Day) before the time fixed for the adjourned General Meeting. A stamp is not required if posted in Great Britain, the Channel Islands or Northern Ireland. A proxy appointment sent by CREST may be treated as invalid in the circumstances set out in Regulation 35(5)(a) of the Uncertificated Securities Regulations 2001. The CREST Manual is available by logging on to www.euroclear.com.

7. The 'Withheld' option on the Form of Proxy is provided to enable you to abstain from the General Meeting Resolution. However, a vote withheld is not counted in law and will not be counted in the calculation of proportion of votes 'For' and 'Against' the General Meeting Resolution.

Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001 (as amended), only those KCOM Shareholders registered in the register of members of the Company as at 10.00 p.m. on 9 July 2019 or, if the General Meeting is adjourned, as at 10.00 p.m. on the day that is two days (excluding any day that is not a Business Day) prior to the General Meeting, will be entitled to vote at the General Meeting in respect of the number of KCOM Shares registered in their name at that time. Changes to entries on the relevant register of members after 10.00 p.m. on 9 July 2019, or if the General Meeting is adjourned, after 10.00 p.m. on the day that is two days (excluding any day that is not a Business Day) prior to the General Meeting, will be regarded in determining the rights of any person to attend or vote at the General Meeting.

12. In the case of joint holders, any one holder may sign. If more than one holder is present at the meeting, or purports to appoint a proxy, only the vote of, or appointment made by, the senior holder may be accepted, seniority being determined by the order in which the names appear on the register. You may not use any electronic address provided either in this Form of Proxy, or in any related documents to the register, to communicate with the Company for any purpose other than those expressly stated.
